## **Proof of Residency Requirements**

Before a student is enrolled in a Utah public school, the student's parent(s) or legal guardian(s) must show proof of residency in the school district which the student desires to attend.

The following documents shall be used in determining residency:

All applicants shall submit at least one document from Column A and two or three, at school district's discretion, from Column B.
